

## General Data Protection Regulation (GDPR) which will apply from 25 May 2018.

Please read all below and sign.

I/We understand that my/our personal information is kept secure and complies with data protection policies and that Club Sx are registered with ICO (Information Commissioner's Office). My/Our information is kept to comply with the club licensing stipulations set by the licensing authority. Nothing will be sent to my/our home address. My/Our information will only be shared if it is believed that I/Us have broken the law on the premises and the police will be given My/Our information. The data Processing officer is Paul Bevon.

Your rights to be informed as a member of Club Sx under the GDPR:

1.Rights, access & data portability of your own personal data for your own use, which is easily accessible. You have to right to access, move,transfer & copy your own personal data. If the personal data concerns more than one individual on the account, we must consider whether providing the information would prejudice the rights of any other individual. There may be a need to contact any individual on the same account the request which may effect this individual. Club Sx have a month to comply. Club Sx has a right to refuse/charge for requests that are manifestly unfounded or excessive. If a request is refuse, we will tell you why and that you have the right to complain to the supervisory authority and to a judicial remedy. We will do this without undue delay and at the latest, within one month. We will need written consent and proof of ID. (Couple account we will need both). 2.Rights of rectification, restrict or object the accuracy of your own personal data. You will need to check & verify the accuracy of your personal data. This is also any change of your own personal data (i.e. Change of addresser name). You can restrict personal data & object to the processing if the data is inaccurate. Also where the process is unlawful. Where you no longer need the personal data. IE: no longer a member of Club Sx. We will do this without undue delay and at the latest, within one month. Two months if the rectification is more complex. We will need written consent and proof of ID (Couple account we will need both). If the personal data concerns more than one individual on the same account, we must consider whether rectifying, restrict or object the accuracy would prejudice the rights of any other individual on the same account. (We may contact this individual).

3.The right to erasure is also know as 'the right to be forgotten'. You as a member you had a right to remove your own personal date where it is no longer necessary in relation to the purpose for which it was originally collected. Also where data was unlawfully held. Where personal data has to be erased in order to comply with a legal obligation. Under the GDPR, this right is not limited to processing that causes unwarranted & damage or distress but may make a case stronger. If a request is refuse, we will tell you why and that you have the right to complain to the supervisory authority and to a judicial remedy. We will do this without undue delay and at the latest, within one month. We will need written consent and proof of ID.(Couple account we will need both.) Once your own personal data has been remove you will no longer be a member of Club Sx. Club Sx right to restrict processing. We can refuse to comply with a request for erasure where the personal data is processed for the following reasons:

To comply with a legal obligation for the performance of a public interest task or exercise of official authority. i.e.: the Police

The exercise or defence of legal claims.

I/We have read and understood my/our rights under GDPR:

To exercise the right of freedom of expression and information; i.e. by requesting a right of erasure you will no longer be-able to be a member of Club Sx. If the right to erasure concerns more than one individual on the account, we must consider whether this would prejudice the rights of any other individual. (We may contact this individual).

I/We confirm that I/We are over 21 and according to 'Challenge 25' alcohol laws, if it appears that I am under 25, I/We will be asked to produce ID to confirm my Date of Birth.
